Use Guidelines

- Application rate for apples is dependent on soil texture. Please check the label prior to application of SOLICAM DF.
- Sequential applications can be made. Do not exceed maximum recommended rate.
- Tank mix with paraquat or glyphosate to broaden spectrum of weed and grasses controlled.
- Pre-Harvest Interval (PHI) = 60 days
