CONTROL ASIAN CITRUS PSYLLID USING LOW VOLUME SPRAYERS

Apply Sevin® XLR Plus using a low volume sprayer for maximum effectiveness against Asian Citrus Psyllid. Thorough and uniform spray coverage is essential for effective control.

Using Sevin XLR Plus in an Asian Citrus Psyllid program introduces an IRAC** **SubGroup 1A** insecticide (carbamate) into a rotation with insecticides of different modes of action.

- For ground application: Apply in sufficient volume for adequate coverage.
- For aerial application: Use at least 10 gallons of spray mixture per acre for adequate distribution.
- Do not apply within 5 days of harvest.
- Do not apply more than a total of 20 quarts per acre per crop.
